

NOW COME Richard Spitalny, Robert & Karen Galloway, Ted & Dina Fitzpatrick, Peter & Aileen Stevenson, Daniel McKeen & Ellen Secord, and Neil & Thomas Russell, by and through their attorney L. Brooke Dingledine, Esq. of the firm Valsangiacomo, Detora & McQuesten, P.C. and hereby amend their response to the Hearing Officer's March 16, 2017 Order Re: Comments on Proposed Schedule as follows:


1. The Site visit dates proposed by the above-referenced parties is hereby amended as it has been determined that April 11 will not be a possible date due to the Passover holiday and Mr. Spitalny's religious observance thereof with his family. He has rearranged a medical appointment which was to occur on April 12 in order to offer that date in lieu of April 11th. **Therefore, the above-referenced parties are available April 6, 7, 12, 13, or 14 for the Site visit.**
2. In addition, undersigned Counsel has determined, contrary to the representation contained in the March 22, 2017 comments filed on behalf of the above-referenced parties, that it does appear that most of the pro se parties have now received a copy of the March 16, 2017 Order from the Board through regular U.S. Mail. However, the time frame for receipt of documents via U.S. Mail when there are such short time frames has led to the pro se parties requesting that the Board email documents directly to them in addition to Regular mail service in order to ensure more timely receipt.

WHEREFORE, the above-referenced parties request that the **Site visit occur on April 6, 7, 12, 13, or 14** and that there be a three week extension

of time for the start of discovery or no earlier than May 8th for the "Discovery Served on Petitioner" deadline with all other deadlines similarly delayed by three weeks.
