Time: 1:00 pm

Meet at the proposed site on Orchard Rd./Wescott Rd. Then proceed to the following locations which are referenced on the attached aerial view map with numbers denoted in **parentheses**:

- Walk to Fitzpatrick's **(10)** on Wescott Road to west of solar site
- Walk to Spitalny's **(9)** on Wescott Road to west of solar site
- Go east on Wescott Road and turn left onto Orchard Rd., travel north to Rte 140. Turn right on Rte. 140 (West St.). Drive east to village center and turn around to drive back west to see views of the proposed site from Rte. 140
- Turn right at Neil Russell's **(2)**
- Go back to Rte. 140 and turn right, then turn right on Sundog Lane to Freilich/Sperling's **(3)** and Gutman-Springsteen [**btwn (3) & (4)**]
- Go back to Rte 140 and turn right, pass by Tom Russell's historic home, **(4)**
- then turn right at 320 West St. Dan McKeen & Ellen Secord's **(5)**
- Walk up hill north to Rocks & Trees field **(6)**
- Drive back down to Rte. 140 and turn right
- Pass by Roy Cooper's 327 West St. on left **(11)**
- Drive west turn right onto Norton Rd.,
- Turn left, just past Rocks and Trees Lane, and go up driveway to Rob and Karen Galloway's **(8)**
