Wells Springs Merger

VOTE - Tuesday, March 7, 2017

The State has approved our plan to consolidate school boards and budgets. The next step is the community vote on March 7.

Thanks to everyone who came out to our community forums. As many of you heard, the State Board of Education approved a plan to consolidate the governance of five school districts in our area into two. Middletown Springs and Wells would combine to form the Wells Springs Unified Union School District and operate grades Pre-K through 6, with full choice for grades 7-12. In a separate merger, Poultney, Proctor, and West Rutland would combine to create the Quarry Valley Unified Union School District and operate grades Pre-K-12. Together, these two mergers would form a "Side by Side," one of the configurations for consolidation that meets the requirements of Act 46.

To move forward, all five communities need to vote YES. In Middletown and Wells, a YES vote means:

- One school board and one budget for the towns of Middletown Springs and Wells.
- Both schools stay open.
- Wells Springs qualifies for tax incentives offered under Act 46.
- Wells Springs retains the Small Schools Grants that each school district currently receives from the State (roughly \$170,000 between both schools).
- There is reduced volatility in school budgets as there will be more students and a larger tax base.
- There are more opportunities for sharing teachers and educational resources to improve student opportunity.
- Middletown maintains full 7-12 choice for its students, and Wells moves from designating Granville to full 7-12 choice.
- Middletown sees lower projected tax rates. (See graph attached to this newsletter.)

If any of the five communities vote NO, there is a short window of opportunity for a revote. **BUT if voters DO NOT APPROVE a merger by July 1, 2017:**

- Middletown Springs would not receive any tax incentives.
- Middletown Springs would its lose Small Schools Grant (roughly \$170,000 between both schools).
- Tax rates would rise to unsustainable levels, threatening the existence of our local elemen-

- tary school. (See graph attached to this newsletter.)
- State Agency of Education would assign Middletown a merger partner and force a consolidation plan of their own design in 2018, but with no incentives.

There will be one more community meeting to discuss the Wells Springs merger proposal before the March 7 vote.

Town Report 2017 Corrections

As you may have already discovered while poring over your Town Report, the Town Budget contains more than one numerical oddity. This note is to correct and explain those numbers that "don't add up" and to let you know that a corrected version of the Report as well as the two pages of the Report containing errors have been posted to the Town's website, www.middletownsprings.vt.gov

These errors do not affect the numbers you will be voting on at Town Meeting and do not change the proposed budget. They are simply errors in layout that were not caught or corrected in the proofreading phase of putting the Report together.

Two errors appear on page 23 of the Report in the General Government section. They are as follows:

- 1. Subtotal Town General for FY 2017 Budget should read \$224,815 instead of \$214,815 (the \$10,000 separately voted for Law Enforcement was not included in the subtotal).
- 2. Subtotal Town General Other for FY 2017 Budget should read \$59,000 instead of \$9,000 (the \$50,000 separately voted for Municipal Facilities was not in the subtotal).

On page 25 there are three erroneous numbers. They are all under the line item Total Town Expenditures and are as follows:

- 1. FY 2016 Budget # should read \$767,412 instead of \$767,4122
- 2. FY 2017 Budget figure should read \$753,798 instead of \$693,798 (\$50,000 missing from the Subtotal Town General Other on page 23 also not included here).
- 3. FY 2018 Proposed Budget figure should read \$653,805 instead of \$743,367 (The appropriations to be voted on were mistakenly included in the total proposed budget number.)

Important Notice to Property Owners

Homestead Declarations are required annually and MUST be filed with the Vermont Tax Department by April 15. However, in 2017 the form is due on April 18. If you plan to file it with your Vermont personal income taxes and you file for an extension, you must still file the Homestead Declaration by April 18. Late filers will be penalized.

What is the Vermont Homestead Declaration?

In Vermont, all property is subject to a statewide education property tax to pay for the state's schools. Property is categorized as either nonresidential or homestead. A homestead is the principal dwelling and parcel of land surrounding the dwelling, owned and occupied by the resident as the person's domicile on April 15, 2017.

Property Tax Adjustment Claim and Eligibility Requirements

The Vermont Property Tax Adjustment assists many Vermont homeowners with paying their property taxes. You may be eligible for a property tax adjustment if your property qualifies as a homestead and you meet the eligibility requirements. The maximum property tax adjustment you can receive is \$8,000. Eligibility requirements are as follows:

- The property must be declared as your homestead.
- You were domiciled in Vermont for the entire 2016 calendar year.
- You were not claimed as a dependent of another taxpayer.
- You own the property as your principal residence on April 1, 2017.
- You meet the household income criteria of \$141,000 or less.

Q&A with the Town Treasurer

When are 3rd Qtr property taxes due? On or before 3/15/17.

Who collects property taxes?

The Town Treasurer - Jenny Talke Munyak - collects current year NON-delinquent taxes.

Can I give my taxes to the Town Clerk?

Current property tax payments should be given to the Treasurer.

What if the Treasurer is not in the office when I want to drop them off?

There are 3 options:

- 1. Mail your taxes to PO Box 1022 and make sure your envelope is postmarked on or before 3/15/17, otherwise you'll incur a late fee. Include a stamped self-addressed envelope if you need a receipt.
- 2. The Treasurer will be available in the Town Office on Wednesday March 15, 9 am-noon and 1 pm-4 pm to receive taxes.
- 3. A dropbox for submission of your taxes will be available in the Town Office during open hours. Include a stamped self-addressed envelope if you need a receipt, or indicate on your envelope that you would like a receipt, and one can be left at the Town Office for you to pick up.

What form of payment do you accept? We accept:

Checks - made out to "The Town of Middletown Springs."

Cash - please submit the exact amount due, as we do not keep cash in the Town Office to make change.

What if I forget to submit my taxes on or before the due date?

Late taxes will incur a late fee. Payments made the day after taxes are due are considered late, and a 1% late fee will be charged. For the two months after that, each month will incur an additional penalty of 1%; after 3 months, a 1.5% charge will be incurred until payment is made.

Maple Festival at MSHS Blends Old and New

RSWSU NEWS


