PROCEDURAL ORDER GRANTING MR. LATTUCA'S REQUEST FOR A CONTINUANCE

This case concerns an application filed with the Vermont Public Utility Commission by Orchard Road Solar I, LLC (the "Applicant") on July 15, 2016, for a certificate of public good, pursuant to 30 V.S.A. §§ 219a and 248, to install and operate a 500 kW group net-metered solar electric power generation system in Middletown Springs, Vermont (the proposed "Project").


On March 20, 2019, I issued an order granting Russell Lattuca's request for an evidentiary hearing. I also established a deadline of March 29, 2019, for Mr. Lattuca to file the testimony and exhibits he had previously filed in support of his request for an evidentiary hearing as prefiled testimony and exhibits available for consideration during the evidentiary hearing.

On March 28, 2019, Mr. Lattuca filed a request for an extension of that deadline for three weeks to submit expert testimony pertaining to aesthetics. The aesthetics of the Project is one of the significant issues to be addressed in the evidentiary hearing. Mr. Lattuca wants the additional time in order that his aesthetics expert, David Raphael, who is traveling and is currently unavailable, may complete his aesthetics review of the Project.

Mr. Lattuca's request is reasonable and is granted. Mr. Lattuca's deadline to file Mr. Raphael's prefiled testimony and exhibits is April 19, 2019.


