PROCEDURAL ORDER CANCELLING EVIDENTIARY HEARING

On May 7, 2019, Orchard Road Solar I, LLC (the "Applicant") filed a stipulation of fact between Russell Lattuca and the Applicant. An additional evidentiary hearing that had been requested by Mr. Lattuca was scheduled in this proceeding for May 14, 2019.

On May 8, 2019, the Vermont Department of Public Service filed comments stating that it had no objections to the stipulation and had no need for the scheduled hearing.

No other party filed comments.

The stipulation removes the need for the hearing scheduled for tomorrow, and it is cancelled. The Applicant is directed to file a revised proposal for decision reflecting the stipulation by no later than the close of business on May 24, 2019.
